London, 18 May 2017: NMC Health plc (LSE:NMC) (“the Company”), the leading integrated healthcare provider operating across the United Arab Emirates (UAE), announces that it has received notification from Mrs Sarah Tompkins, the spouse of Mr H J Mark Tompkins, Joint Non-Executive Chairman of the Company, that on 15 May 2017 she sold 1,000 ordinary shares of 10p each in the Company (“Shares”) at a price of 2,098.00p per share.
