**London, 12 June 2017:** NMC Health plc (LSE:NMC) ('the Company'), the leading integrated healthcare provider operating across the United Arab Emirates (UAE), announces that it has received notification from Mr H. J. Mark Tompkins, Joint Non-Executive Chairman of the Company, that on 9 June 2017 he sold 1,000 ordinary shares of 10p each in the Company ("Shares") at a price of 2,300p per share.
